February Program:

Birding In the Land of the Thunder- Dragon –Bhutan.

Tue Feb 12, 7:30 pm College Park Airport

The Himalayan kingdom of Bhutan is one of the world's premier birding destinations, both for its variety of superb species and its enlightened environmental policies that have protected the extensive forests and their wildlife. Only open to tourism since 1979, Bhutan welcomes birders and other lovers of natural beauty. Gail Mackiernan, her husband, and three friends traveled to Bhutan in 2005, and Gail will share their birding experiences in her presentation. Gail Mackiernan is by training a marine biologist. Her area of expertise is the Chesapeake Bay, and she worked throughout her professional life on this estuary. While with the EPA Chesapeake Bay Program she coauthored the reports on the health of the Bay and necessary management actions. Later, as research director for the University of Maryland Sea Grant College, she oversaw studies in a wide range of disciplines from fisheries to biotechnology, all directed towards the Bay and its ecology. She retired from the University in 1997.

Gail started bird-watching seriously in high school, then took a break during grad school, only to revive her interest about 25 years ago. Since then, along with her husband Barry Cooper, she has traveled to all 7 continents in search of birds. Most recently returned from the Philippines, they are off later this month to Ethiopia.

March Program

Forensic Ornithology: Identifying birds from Feather Clues"

Tue Mar 12, 7:30 pm College Park Airport

If you think identifying birds from photographs is difficult, try using downy feather barbs. This presentation will demonstrate how Dr. Carla Dove uses microscopic feather clues to aid in the identification of birds. An important application of this research is to the field of aviation safety in determining the identifications of birds that are ingested into aircraft engines (bird-strikes) such as the one that caused US Airways flight 1549 to crash into the Hudson River on 15 January 2009. Dr. Dove often collaborates with scientists in the fields of Anthropology, Ecology, and Evolutionary Biology, and has served as a consultant to the U.S. Fish and Wildlife Service Law Enforcement Division, the Federal Bureau of Investigation, the U.S. Air Force, the U.S. Navy, U.S. Customs, the USDA Wildlife Services, the Federal Aviation Administration, the National Transportation Safety Board, and many aircraft engine manufacturers.

Carla J. Dove is a Research Scientist in the Division of Birds at the National Museum of Natural History where she is head of the Feather Identification Lab.
